### UNPO XIII General Assembly Convened in Edinburgh

2 July 2017

Over the last two years, countless global events have afflicted the world and peoples across borders, oceans, and disputed territories. In many parts of the world, minority and indigenous rights are under siege. As a result of authoritarianism, governmental neglect, marginalisation, state-sponsored repression or outright violence, many minority and indigenous groups do not even have the right to be physically safe, let alone to participate politically, thrive and achieve their full potential. Civil unrest and violent conflict driven by economic and geopolitical interests put an additional strain on minorities and are devastating communities in the Middle East, Asia, Africa, Eastern Europe, and Latin America. A general lack of stability, growing radical populism, and epochal migrations, adding up to millions of displaced peoples and refugees, are undermining public support for minority rights, peace and democratic growth.

These times of uncertainty make UNPO's work all the more important. Since the organisation's XII General Assembly in 2015, the organisation and its members have continued to work assiduously to promote the protection of the rights of the unrepresented worldwide. Assisting our members in achieving their self-defined goals through work with international human rights mechanisms, organisational capacity development and dissemination of credible information continued to be an integral element of UNPO's mission. Together, we performed an impressive number of initiatives, international campaigns, fact-finding missions, trainings, workshops, and very effective political lobbying and advocacy work in several Parliaments.

Yet, there is plenty to learn and even more to gain in future endeavours. On the occasion of UNPO's XIII General Assembly which took place in Edinburgh, Scotland, on 26-28 June, representatives of 25 unrepresented nations and peoples gathered to discuss the challenges and opportunities that lie ahead. The opening conference, entitled "Sharing Perspectives on the Rights of the Unrepresented", hosted by Willie Rennie MSP (Scottish Liberals) gave representatives of indigenous groups and minorities, as well as academics, activists and politicians a platform for constructive debates around questions of identity and intersectionality, focusing, for instance, on how women, LGBT groups and refugees coming from an unrepresented background face a double discrimination.

The official part of UNPO's General Assembly gave room for representatives of UNPO members to assess the organisation's performance in the last two years and to discuss its future. An evening reception at the Scottish Parliament reception hosted by Joan McAlpine MSP (Scottish National Party) then focused on the theme of self-determination in the globalised age. The event took a closer look at the increasing challenges that unrepresented nations and peoples face amidst abovementioned worrying developments on a global scale, and allowed for a fruitful discussion on how to overcome these challenges.

A cross-cutting theme throughout the three-day General Assembly was the important question of gender equality. In a milestone decision, members not only committed to continue promoting gender equality in all aspects of their works, but to attempt to advance gender balance within their own representative body. UNPO and its members reiterated their unwavering commitment to their core principles: non-violence, democracy, self-determination, tolerance, environmental protection, and human rights. These may be challenging times, but the difficulties we face will make us more determined to achieve our objectives.

### UYGHUR AND TIBETAN PROTEST, BRUSSELS

#### 2 June 2017

UNPO representatives joined a protest organised by International Campaign for Tibet, the International Federation for Human Rights (FIDH) and Amnesty International. The demonstration took place on the occasion of Chinese Premier Li Keqiang's meetings with high-ranking EU officials in Brussels. ### ANNUAL KKF CEREMONY, CHAMPS-SUR-MARNE

#### 4 June 2017

The Khmer Kampuchea-Krom Federation hosted a commemorative ceremony on the occasion of the anniversary of the colonisation of Kampuchea Krom by Viet Nam, which took place 68 years ago. The ceremony was attended by a UNPO representative and was an occasion to honour the people, monks and activists, who stand up and advocate for the rights of Kampuchea-Krom communities. ### EP CONFERENCE ON IRAQI MINORITIES, BRUSSELS

#### 6 & 7 June 2017

Hosted by MEPs Ana Gomes and Elmar Brok, a conference on Iraqi minorities entitled "Post-ISIS Ninewa: European Response" brought together representatives of the country's various minorities, policy-makers, as well as research experts. Made possible by the financial support of Konrad-Adenauer Stiftung and organised together with No Peace Without Justice and the Institute for International Law and Human Rights, the event raised awareness of the precarious situation of Irag's minorities and discussed ways forward for a post-ISIS era. UNPO and its partner organisations released their third report on the alarming situation of Irag's minorities, based on a fact-finding mission which had been conducted earlier this year. ### UNPO XIII GENERAL ASSEMBLY, EDINBURGH

26-28 June 2017

At UNPO's XIII General Assembly. around 25 of the organisation's members from across the globe met in Edinburgh, Scotland, to take a look back, while also discussing the direction UNPO should take in the following few years. Before the opening of the General Assembly, UNPO, in collaboration with the Third Generation Project (TGP) and MSP Willie Rennie (Scottish Democrats), convened a conference entitled 'Sharing Perspectives on the Rights of the Unrepresented on the Eve of UNPO's XIII General Assembly'. Representatives of indig-General enous groups and minorities, as well as academics, activists and politicians addressed some of the major issues they face as regards questions of identity, pointing out how women, LGBTQ groups and refugees, for instance, often face double discrimination according to the principle of intersectionality. At the end of the first day, an evening reception organised by TGP gave UNPO academics, and the members, members of Scotland's development and human rights community the opportunity to network and continue the fruitful exchange of views. On the second day of the General Assembly, UNPO held a <u>reception at the Scottish</u> Par<mark>liament, hosted by MSP Joan</mark> McAlpine. It focused on the theme of self-determination in the globalised age, looking at how the unrepresented can collaborate and unite their efforts. On 28 June, the representatives voted on member-specific resolutions, as well as a general one, all of which were adopted by the assembly. Mr Marino Busdachin, Mr Nasser Boladai and Mr Abdirahman Mahdi were re-elected as Secretary General. President and Vice-President, while Mr Dolkun Isa was elected as second Vice-President. #### ITI ADVOCACY MEETINGS, BRUSSELS

6-9 June 2017

Representatives of the <u>Ilham Tohti</u> <u>Initiative</u> (ITI), <u>ChinaChange.org</u> and UNPO conducted a round of advocacy meetings as a follow-up to the candidacy of imprisoned human rights activist Ilham Tohti who had been nominated for the Sakharov Prize after effective advocacy work by UNPO and its partners. Other issues discussed were the European Union's involvement in the One Belt One Road project and follow-up on the launch of a Uyghur friendship group at the European Parliament.

### ROUNDTABLE INTERVIEW ON HUMAN RIGHTS IN CHINA

During an interview at the TV studios of the European Parliament, a UNPO representative and Uyghur activists discussed the case of imprisoned activist Ilham Tohti and the overall human rights situation in China in light of the latest geopolitical developments. UNPO participated in a panel discussion organised by Stand Up for Europe Bruxelles, entitled 'The EU and Human Rights: External Leadership, Internal Inaction?". UNPO Project Officer Lukas van Diermen used the examples of the Guarani-Kaiowá in Brazil and the Oromo and Ogaden in Ethiopia to illustrate the divergences within the EU external policy regarding human rights issues, and in what ways UNPO continues to push European Institutions for a more consistent and active approach.

### LEZGHIN ADVOCACY MEETINGS, BRUSSELS

#### 28-29 June 2017

Representatives of UNPO and Mr Gusen Shakhpazov, member of the Federal National and Cultural Lezghin Autonomy Advocacy (FLNCA). conducted a round of advocacy meetings with Members of the European Parliament to discuss the dire social and economic situation of national minorities in Azerbaijan and to address in particular the numerous human rights abuses faced by the Lezghin community in the country.

#### BATWA DOCUMENTARY SCREENING "FOG OF BWINDI", BRUSSELS

10 July 2017

Made possible by the generous support of the Nando and Elsa Peretti Foundation, UNPO will organise and host a screening of the documentary "Fog of Bwindi" Cinema Aventure in Brussels. The documentary tells the story of the Batwa, who for thousands of years lived peacefully as hunter-gatherers in the Bwindi forest within the southwestern region of Uganda and their human rights situation ever since the Bwindi forest has been designated a world heritage site by UNESCO.
